

# **PUBLIC NOTICE:** Launch of call of modification of 8 SX settler tanks.

#### 11 July 2024

MMG Kinsevere SARL hereby announces to the public the launch of the tender for the Modification of 8 SX Settler Tanks to improve ergonomics and accessibility for regular maintenance activities.

MMG invites all interested <u>ARSP registered</u> and qualifying tenderers to submit their Company Profile (**English version**) of their respective company and the list of compliant documents detailing their expression of interest for the above tender by **no later than 31 July 2024**.

MMG will use the submitted information to assess the compatibility and the capability of the tenderers in relation to this specific tender. Failure to submit complete and accurate information by the interested tenderers will result in summary rejection of eligibility to tender.

#### 1. SUMMARY DESCRIPTION OF WORKS :

MMG Kinsevere has projected to do some modification of 8 SX Settler Tanks to improve ergonomics and accessibility for regular maintenance activities. This summary outlines the requirements for the modification, considering the existing roof supporting posts and structural integrity. The description is applied to one settler, but project executive must be extended to all 8 Settlers.

The scope of work includes 3 parts, (i) Settler Tanks roof height increasing, (ii) wall plates installation along SX Settler and (iii) Installation of two access corridors above the settler. The engineering design will be completed by the contractor and submitted to MMG Kinsevere for review and approval prior to execution.

## 2. COMPLIANCE DOCUMENTS :

- The Registration certificate in ARSP (Private Sector Subcontracting Regulatory Authority), mandatory.
- Notarized Articles of incorporation/ certificate of its deposit to the RCCM
- Legal documents from competent authorities having a RCCM number, a National Identification number and a NIF number.
- Document stating that your company is in good standing with the local Tax Authorities
- Proof of affiliation to the Social Security Organisation (CNSS)
- Proof of affiliation to the National Institute of Professional Preparation (INPP)
- Proof of registration with the National office of Employment (ONEM)
- Proof of Insurance
- Legally required qualifications to carry out the above construction works and design.

Note that the list above is not a definitive/exhaustive list and additional documents may be required at any time depend on our legal analysis/reviews.

## 3. FINANCIAL STABILITY :

Service Providers to submit Financial Audited statements for a period of the last 2 years detailing annual turnover and all other financial pertinent matters.

Bidders may be required to provide a sworn affidavit that it has not been previously blacklisted, suspended or is currently involved any in disputes or penalty claims whether previous or current relating to any contracts undertaken.

## 4. **REFERENCES**:

Submit a list of similar projects/ works previously undertaken by the company including Client information, Contract Value, Contactable references for each project.

The said references need to be mining specific. Experience in providing such services in the DRC mining industry will be advantageous.
